RESOLUTION NO. 09-292

RESOLUTION APPOINTING ONE (1) COMMISSIONER TO THE LAFOURCHE PARISH HEROES MONUMENT COMMISSION.

WHEREAS, Ordinance No. 4360, adopted at the August 12, 2008 meeting of the Lafourche Parish Council, created the Heroes Monument Commission; and

WHEREAS, the commission is comprised of nine (9) members, all which shall be electors domiciled outside of Ward 10; and five (5) of which shall be Honorably Discharged Veterans of a Branch of the U. S. Armed Forces; two (2) members shall have been employed as a Commission Police Officer for a minimum of five years; and two (2) members shall have served as a fireman for a minimum of five years; and

WHEREAS, Forest Travirca IV and Albert Martin, Sr. submitted their resignation were appointed in the firemen category; and

WHEREAS, these positions were advertised and Kevin Braud submitted his application to fill one (1) position for a member to serve in the fireman category; and

WHEREAS, this resolution was sponsored for Administration by Mr. Michael Delatte, District 2; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this application.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on August 11, 2009, and does hereby appoint Mr. Kevin Braud to the Lafourche Parish Heroes Monument Commission to serve a one (1) year term beginning August 11, 2009 and ending August 10, 2010.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to Mr. Kevin Braud, 2022 Hwy 1, Raceland, LA 70394; and the Office of Grants and Economic Development.
