

On motion by Phillip Gouaux, seconded by Lindel Toups, the following resolution was introduced and adopted;

RESOLUTION NO. 09-295

RESOLUTION APPROVING A CONTRACT WITH THE SCHOOL FOOD AND NUTRITION SERVICES OF NEW ORLEANS, INC. TO PROVIDE FOOD SERVICES TO THE LAFOURCHE PARISH HEAD START SITES AT SOUTH LAFOURCHE 1, 2, & 3, AND MGC (LOCKPORT) 1, 2, 3, & 4 AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID CONTRACT AND ANY AND ALL RELEVANT DOCUMENTS AND AMENDMENTS.

WHEREAS, the School Food and Nutrition Services of New Orleans, Inc. has offered the Lafourche Parish Head Start a contract to provide food services; and

WHEREAS, the food services will consist of three (3) meals per day; breakfast at \$1.65, lunch at \$3.30, and a snack at \$0.75, for a total of \$5.70 per day; and

WHEREAS, this contract is for the term of nine (9) months commencing from August 24, 2009 and ending on the last day of school in May, 2010; and

WHEREAS, this resolution was sponsored for Administration by Mr. Phillip Gouaux, Councilman, District 7; and

WHEREAS, it is the recommended by the Administration of the Lafourche Parish Government that the Council approves said contract with the School Food and Nutrition Services of New Orleans, Inc. to allow the Lafourche Parish Head Start to provide the services governed by this agreement; and authorizes the Parish President to sign, execute, and administer said contract and any and all relevant documents and amendments.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on August 11, 2009, and does hereby approve a contract with the School Food and Nutrition Services of New Orleans, Inc. to provide food services to the Lafourche Parish Head Start sites as listed; and authorizes the Parish President to sign, execute, and administer said contract and any and all relevant documents and amendments.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to School Food and Nutrition Services of New Orleans, Inc. 1000 Howard Ave., Suite 300 New Orleans, LA 70113-1925; Lafourche Parish Government Department of Head Start, Department of Finance, and the Office of the Parish Administrator.
