

On motion by Daniel Lorraine, and seconded by Rodney Doucet, the following resolution was introduced and adopted:

**RESOLUTION NO. 09-303**

**RESOLUTION REQUESTING THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT (LADOTD) TO CONSIDER INSTALLING A LIST OF SIGNS OFF OF LA 1 ON THE RIGHT HAND SIDE TO IDENTIFY THE BUSINESS PLACES BEFORE THE TURN OFF TO THE TOMMY DOUCET BRIDGE.**

**WHEREAS**, due to the road turning off before the businesses, these businesses have suffered sales due to the bridge turn off lane; and

**WHEREAS**, the following businesses needing help are: two (2) convenience stores (gas and deli); three (3) restaurants; one (1) motel, four (4) seafood sheds; four (4) bait shops; two (2) trailer parks, five (5) campgrounds (rv parks); two (2) oilfield boat docks; one (1) boat launch and one (1) bar; and

**WHEREAS**, the State (DOTD) should fully fund this project.

**BE IT RESOLVED**, by the Lafourche Parish Council convened in regular session on August 25, 2009, that it does hereby request the Louisiana Department of Transportation and Development (LADOTD) to consider installing a list of signs off of LA 1 on the right hand side to identify the business places before the turn off to the Tommy Doucet Bridge.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution be forwarded to Governor Bobby Jindal, Representatives Jerry “Truck” Gisclair, Jerome “Dee” Richard, Damon Baldone, Gordy Dove; Speaker of the House Jim Tucker; Speaker of the Senate Joel Chaisson; and the Office of the Parish Administrator.
