RESOLUTION NO. 09-304

RESOLUTION REQUESTING THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT (LADOTD) TO CONSIDER INSTALLING MORE KIOSK MACHINES FOR GEAX PASSES.

WHEREAS, DOTD has installed four (4) kiosk machines throughout the Parish and should consider installing a few more; and

WHEREAS, one (1) should be installed at Griffin’s Marina in Leeville, LA due to the fact they have been in business for over thirty-five (35) years; and

WHEREAS, many residents are stopping at Griffin’s Marina to purchase a Geaux Pass and they are not equipped with a kiosk machine; and

WHEREAS, DOTD should consider paying for the installation of the kiosk machine at Griffin’s Marina.

BE IT RESOLVED, by the Lafourche Parish Council convened in regular session on August 25, 2009, that it does hereby request the Louisiana Department of Transportation and Development (LADOTD) to consider installing more kiosk machines for Geaux Passes.
