RESOLUTION NO. 09-312

A RESOLUTION ACCEPTING THE QUOTE OF VESCO TENNIS COURTS, INC. IN THE AMOUNT OF EIGHT THOUSAND EIGHT HUNDRED EIGHTY NINE DOLLARS (\$8,889.00) FOR THE RESURFACING OF THE RACELAND TENNIS COURTS AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER ANY AND ALL ASSOCIATED DOCUMENTS.

WHEREAS, funding for this project was approved at the August 11, 2009, Lafourche Parish Council meeting; and

WHEREAS, Vesco Tennis Courts, Inc. submitted a proposal to resurface both Raceland tennis courts at a cost of \$8,889.00; and

WHEREAS, this resolution was sponsored for the Administration by Mr. Michael Delatte, Councilman, District 2; and

WHEREAS, it is the recommendation of the Administration that the quote of Vesco Tennis Courts, Inc. be accepted; and

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on August 25, 2009, and does hereby accept the bid of eight thousand eight hundred eighty nine dollars (\$8,889.00) by Vesco Tennis Courts, Inc. for the resurfacing of the Raceland tennis courts; and authorizing the Parish President to sign, execute and administer any and all relevant documents.
