**RESOLUTION NO. 09-324**

**A RESOLUTION ACCEPTING THE LOW BID FOR LOUISE/EAU CLAIRE PROJECT IN THE AMOUNT OF \$94,786.51 FROM ALAN ARCEMENT AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID CONTRACT AND ASSOCIATED DOCUMENTS.**

**WHEREAS**, bids were received and read publicly on August 31, 2009; and

**WHEREAS**, there were 7 bidders of which 2 did not qualify with the low bidder being Alan Arcement in the amount of \$94,786.51; and

**WHEREAS**, it is the recommendation of the Administration of Lafourche Parish Government that the low bid of \$94,786.51 be accepted; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Jerry Jones, Councilman, District 1; and

**WHEREAS**, it is the recommended by the Administration that the Lafourche Parish Council accept the low bid of \$94,786.51 from Alan Arcement for the Louise/Eau Claire Project and authorizes the Parish President to sign, execute, and administer said contract and any and all relevant documents.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on September 8, 2009, and does hereby accept and approve the low bid of \$94,786.51 from Alan Arcement for the Louise/Eau Claire Project and authorizes the Parish President to sign, execute, and administer said contract and any and all related documents.
