RESOLUTION NO. 09-326

RESOLUTION TO NEGOTIATE A CONTRACT TO HIRE RICHARD G. WEIMER ARCHITECT, AIA, LLC FOR THE INTERIOR REMODELING OF THE LAFOURCHE PARISH GOVERNMENT COMPLEX, MATHEWS AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, the Lafourche Parish Government purchased the old Wal-Mart Building in Mathews, Louisiana on August 13, 2009; and

WHEREAS, the interior work will include but not be limited to the construction of the Council Chambers and Executive Session Room, reception area, and departmental walls; and

WHEREAS, funding for the interior work is being applied for through a Community Development Block Grant; and

WHEREAS, this resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves hiring Richard G. Weimer Architect, AIA, LLC for the interior remodeling of the Lafourche Parish Government Complex, Mathews and authorizes the Parish President to sign, execute, and administer any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on September 8, 2009, and does hereby authorize the Parish President to negotiate a contract to hire Richard G. Weimer Architect, AIA, LLC for the interior remodeling of the Lafourche Parish Government Complex, Mathews and authorizing the Parish President to sign, execute, and administer any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to Richard G. Weimer Architect, AIA, LLC, 307 Canal Boulevard, Thibodaux, LA 70301; Lafourche Parish Government Department of Finance, Department of Parks, Recreation, and Public Facilities, and the Office of the Parish Administrator.
