**RESOLUTION REAPPOINTING ONE (1) COMMISSIONER TO REPRESENT THE TOWN OF LOCKPORT ON THE LAFOURCHE PARISH FIRE PROTECTION DISTRICT NO. 2 BOARD.**

**WHEREAS**, Mr. Frank Daviet serves on the Lafourche Parish Fire Protection District No. 2 Board and represents the Town of Lockport on the Board; and

**WHEREAS**, according to the Lafourche Parish Government's records, Mr. Daviet's term expired on August 27, 2009; and

**WHEREAS**, the Town of Lockport, recommends Mr. Daviet be reappointed to the Lafourche Parish Fire Protection District No. 2 Board; and
