RESOLUTION NO. 09-333

RESOLUTION APPROVING THE HIRING OF MARTIN GLYNN OF TRI PARISH APPRAISAL AT A FEE OF \$4,200.00 FOR THE PURPOSE OF APPRAISING THE PROPERTY LOCATED AT 1612 HIGHWAY 182, RACELAND, LOUISIANA (BARRIOS BUILDING) AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, an appraisal is necessary to determine the “Fair Market Value” of said property; and
