RESOLUTION NO. 09-339

RESOLUTION REQUESTING THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT (LADOTD) TO CONSIDER HANGING “NO TURN ON RED” SIGNS ON THE TRAFFIC LIGHT AT THE SOUTH LAFOURCHE BRIDGE ON BOTH LA 1 AND HIGHWAY 308 IN GALLIANO, LOUISIANA, WARD (10), DISTRICT (9), PARISH OF LAFOURCHE, STATE OF LOUISIANA.

WHEREAS, the Lafourche Parish Council has made and continues to make requests to the Louisiana Department of Transportation and Development which concerns the general health, safety and welfare of the citizens of the Parish; and

WHEREAS, it is important that motorists are able to see this sign for their safety; and

WHEREAS, at all other bridges it is hanging from the traffic lights; therefore,

BE IT RESOLVED, by the Lafourche Parish Council convened in regular session on September 22, 2009, that it does hereby request the Louisiana Department of Transportation and Development (LADOTD) to consider hanging “No Turn On Red” signs on the traffic light at the South Lafourche Bridge on both LA1 and Highway 308 in Galliano, Louisiana, Ward (10), District (9), Parish of Lafourche, State of Louisiana.
