RESOLUTION NO. 09-340

RESOLUTION REQUESTING THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT (LADOTD) TO CONSIDER CLEANING OUT THE CULVERTS AND SWEEPING OUT HIGHWAY DITCHES FROM EAST 138TH STREET TO EAST 140TH STREET AND EAST 147TH STREET TO EAST 152ND STREET AND EAST 128TH STREET IN GALLIANO, LOUISIANA, WARD (10), DISTRICT (9), PARISH OF LAFOURCHE, STATE OF LOUISIANA.

WHEREAS, the Lafourche Parish Council has made and continues to make requests to the Louisiana Department of Transportation and Development which concerns the general health, safety and welfare of the citizens of the Parish; and

WHEREAS, these people drain to the bayou and these ditches need to be swept out and the culverts need to be cleaned; and

WHEREAS, this will help these residents with flooding that occurs every time it rains; therefore,

BE IT RESOLVED, by the Lafourche Parish Council convened in regular session on September 22, 2009, that it does hereby request the Louisiana Department of Transportation and Development (LADOTD) to consider cleaning out the culverts and sweeping out highway ditches from East 138th Street to East 140th Street and East 147th Street to East 152nd Street and East 128th Street in Galliano, Louisiana, Ward (10), District (9), Parish of Lafourche, State of Louisiana.
