RESOLUTION AMENDING THE LAFOURCHE PARISH CITIZEN PARTICIPATION PLAN FOR LOUISIANA COMMUNITY DEVELOPMENT BLOCK GRANT (LCDBG) AND COMMUNITY DEVELOPMENT BLOCK GRANT DISASTER RECOVERY (CDBG-DR) PROGRAMS REGARDING TIME LINES FOR PUBLIC HEARINGS AND COMPLAINT PROCEDURES AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.
