**RESOLUTION TO ADOPT RESIDENTIAL ANTIDISPLACEMENT AND RELOCATION ASSISTANCE PLAN AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, the Lafourche Parish will receive Gustav/Ike Community Development Block Grant Disaster Recovery (CDBG-DR) Program funds and may receive a Louisiana Community Development Block Grant (LCDBG) Program in the coming fiscal year; and

**WHEREAS**, the both CDBG-DR and LCDBG Programs requires that all grant recipients adopt by resolution a Residential Antidisplacement and Relocation Assistance Plan; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approves to adopt the Residential Antidisplacement and Relocation Assistance Plan and authorizes the Parish President to sign, execute, and administer any and all relevant documents.
