RESOLUTION NO. 09-364

RESOLUTION RESCINDING RESOLUTION NO. 09-296 THAT REQUESTED ADMINISTRATION TO WAIVE THE FEE OF \$1200.00 CHARGED TO DR. STEPHEN MORRIS FOR GRASS CUTTING DUE TO A MISUNDERSTANDING.

WHEREAS, due process was followed according to Ordinance No. 3895, which was amended to create Ordinance No. 4538 by Council; and

WHEREAS, after legal review of the file, the file was in order to proceed; and

WHEREAS, the Department of Solid Waste followed the Ordinance and took action to comply with said Ordinance; and

WHEREAS, the Council approved Ordinance 09-296 waiving said fees; and

WHEREAS, the actual bill for service was \$1,246.25; and

WHEREAS, this resolution was sponsored for Administration by Mr. Michael Delatte, Councilman, District 2; and

WHEREAS, after discussion by Council, it is recommended that the Council hereby rescinds, in its entirety, resolution no. 09-296 that requested the Administration to waive the fee of \$1200.00 charged to Dr. Stephen Morris for grass cutting due to a misunderstanding.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on September 22, 2009, and does hereby rescind, in its entirety, Resolution No. 09-296 that requested the Administration to waive the fee of \$1200.00 charged to Dr. Stephen Morris for grass cutting due to a misunderstanding.
