RESOLUTION REQUESTING THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT (LADOTD) TO INSTALL OVERHEAD WARNING LIGHTS OR FULL TRAFFIC LIGHTS AND THEN REMOVE THE “NO PARKING” SIGN IN FRONT OF THE MEDICAL OFFICE OF DR. TIMOTHY MAINES AND DR. KARL GERALD HAYDEL, 3916 HWY 1, RACELAND, LOUISIANA, WARD (3), DISTRICT (5), PARISH OF LAFOURCHE, STATE OF LOUISIANA.

WHEREAS, the Lafourche Parish Council has made and continues to make requests to the Louisiana Department of Transportation and Development which concerns the general health, safety and welfare of the citizens of the Parish; and

WHEREAS, removal of this sign is being requested because it is preventing patients from parking on Hwy. 1 as allowed by other businesses; therefore

BE IT RESOLVED, by the Lafourche Parish Council convened in regular session on September 22, 2009, that it does hereby request the Louisiana Department of Transportation and Development (LADOTD) to **install overhead warning lights or full traffic lights and then** remove the “No Parking” sign in front of the medical office of Dr. Timothy Maines and Dr. Karl Gerald Haydel, 3916 Hwy. 1, Raceland, Louisiana, Ward (3), District (5), Parish of Lafourche, State of Louisiana.
