

On motion by Matt Matherne, seconded by Phillip Gouaux, the following resolution was introduced and adopted:

RESOLUTION NO. 09-368

RESOLUTION REQUESTING THE INSTALLATION OF CULVERTS BE CLARIFIED BY THE ADMINISTRATION AND THE LAFOURCHE PARISH DISTRICT ATTORNEY AS TO: (1) WHAT THE PARISH CAN INSTALL; (2) IF THE PARISH CAN PURCHASE CULVERTS; (3) WHICH CULVERTS CAN BE INSTALLED: DRIVEWAY, LANDSCAPING, COMBINATION OF DRIVEWAY AND LANDSCAPING AND A CLARIFICATION TO SEPARATE THE TWO AND (4) DOES THE PROPERTY OWNER'S FOOTAGE HAVE ANY DETERMINATION AS TO ONE (1) DRIVEWAY PER RESIDENCE OR PER PROPERTY OWNER (I.E. BUSINESS LOCATIONS, CHURCHES, AND NON-PUBLIC BODIES SUCH AS THE LIONS CLUB, THE KNIGHTS OF COLUMBUS AND THE ELKS LODGE).

WHEREAS, it is the duty upon oath that the Governing Authority and State Officials address concerns dealing with the general health, safety and welfare of the citizens and said resolution satisfies this criteria; therefore

BE IT RESOLVED, by the Lafourche Parish Council convened in regular session on October 13, 2009, that it does hereby request the installation of culverts be clarified by the Administration and the Lafourche Parish District Attorney as to: (1) what the Parish can install; (2) if the Parish can purchase culverts; (3) which culverts can be installed: driveway, landscaping, combination of driveway and landscaping and a clarification to separate the two and (4) does the property owner's footage have any determination as to one (1) driveway per residence or per property owner (i.e. business locations, churches, and non-public bodies such as The Lions Club, The Knights of Columbus and The Elks Lodge).

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to the Lafourche Parish District Attorney; and the Office of the Parish Administrator.
