**RESOLUTION REAPPOINTING ONE (1) COMMISSIONER TO REPRESENT LAFOURCHE PARISH SCHOOL BOARD ON THE LAFOURCHE PARISH YOUTH AND PLANNING BOARD.**

**WHEREAS**, Mr. Ray Bernard, serves on the Lafourche Parish Children and Youth Planning Board and represents Lafourche Parish School Board on the Board; and

**WHEREAS**, according to the Lafourche Parish Government's records, Mr. Ray Bernard's term expired on October 8, 2009; and
