RESOLUTION APPOINTING ONE (1) COMMISSIONER TO THE VETERANS' MEMORIAL DISTRICT OF WARD 10 OF LAFOURCHE PARISH BOARD.

WHEREAS, Mr. Clyde Orgeron, was recommended by the Delvin Adams American Legion Post 315; and

WHEREAS, Mr. Clyde Orgeron was appointed on March 10, 2009; and

WHEREAS, according to the Lafourche Parish Government's records, Mr. Clyde Orgeron submitted his resignation in September, 2009; and
