

On motion by Daniel Lorraine, and seconded by Rodney Doucet, the following resolution was introduced and adopted:

RESOLUTION NO. 09-342

RESOLUTION REQUESTING THE ADMINISTRATION TO FOLLOW THE RECOMMENDATIONS AS STATED IN THIS RESOLUTION CONCERNING PARISH BRIDGES (PONTOON BRIDGES) (GALLIANO, COTE BLANCHE AND VALENTINE).

WHEREAS, the recommendations are as follows:

WHEREAS, that we maintain these bridges weekly and if there is a problem the Council should be notified immediately; and

WHEREAS, once a year all anodes are to be checked out with a diver; and

WHEREAS, every four (4) to five (5) years, bridges need to be brought to the shipyard for bottom job (anodes, sweep bottoms, and paint job); and

WHEREAS, as the Galliano Bridge had a bottom job and was put back in the water in July, 2009; and

WHEREAS, this would be for the betterment of the public and the safety of all residents; therefore,

BE IT RESOLVED, by the Lafourche Parish Council convened in regular session on September 22, 2009, that it does hereby request the Administration to follow the recommendations as stated in this resolution concerning the Parish bridges (Pontoon Bridges) (Galliano, Cote Blanche, and Valentine).

BE IT FURTHER RESOLVED, that a certified copy of this resolution be forwarded to the Department of Public Works and the Office of the Parish Administrator.
