RESOLUTION REAPPOINTING ONE (1) COMMISSIONER TO REPRESENT THE THIBODAUX CITY COURT ON THE LAFOURCHE PARISH YOUTH AND PLANNING BOARD.

WHEREAS, Mrs. Linda Boudreaux, serves on the Lafourche Parish Children and Youth Planning Board and represents Thibodaux City Court on the Board; and
