

On motion by Joe Fertitta, seconded by Phillip Gouaux, the following resolution was introduced and adopted;

**RESOLUTION NO. 09-356**

**RESOLUTION APPROVING AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE NORTH LAFOURCHE CONSERVATION, LEVEE & DRAINAGE DISTRICT (NLCLDD) AND LAFOURCHE PARISH GOVERNMENT (PARISH) FOR THE PURPOSE OF THE OPERATION AND MAINTENANCE OF THE VOLVO WETLANDS MARSH BUGGY EXCAVATOR; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID AGREEMENT AND ANY AND ALL RELATED DOCUMENTS.**

**WHEREAS**, the purpose of the agreement is for the operation and maintenance of Volvo Wetlands Marsh Buggy Excavator purchased and owned by NLCLDD; and

**WHEREAS**, said purchase of equipment is consistent with the common goal of NLCLDD and Parish to provide and maintain levees/drainage for the benefit of the public; and

**WHEREAS**, both parties have agreed to share in the responsibility for the costs incurred in operation and maintaining the Volvo Wetlands Marsh Buggy Excavator; specifically noting in the agreement that Parish and NLCLDD will share the extraordinary fuel cost as per Resolution passed by North Lafourche Conservation, Levee & Drainage District on July 29, 2009 (see attached); and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Joe Fertitta, Councilman District 4; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approve said Intergovernmental Agreement between NLCLDD and Parish for the operation and maintenance of the Volvo Wetlands Marsh Buggy Excavator; and authorizing the Parish President to sign, execute, and administer said agreement and any and all relevant documents; and

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on September 22, 2009, and does hereby approve the Intergovernmental Agreement between the NLCLDD and Parish for the operation and maintenance of the Volvo Wetlands Marsh Buggy Excavator; and authorizes the Parish President to sign, execute, and administer said agreement and any and all relevant documents.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution shall be forwarded to; Mr. Ronald Adams, President of NLCLDD, Post Office Drawer 230, Raceland, LA 70394; Lafourche Parish Government Finance Department, Department of Public Works, and the Office of the Parish Administrator.
