

On motion by Lindel Toups, seconded by Joe Fertitta, the following resolution was introduced and adopted;

**RESOLUTION NO. 09-357**

**RESOLUTION AUTHORIZING THE SUBMISSION OF AN APPLICATION UNDER THE FY2010-2011 LOUISIANA COMMUNITY DEVELOPMENT BLOCK GRANT (LCDBG) PROGRAM FOR CONSTRUCTION OF A COMMUNITY CENTER IN ALIDORE; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, Lafourche Parish has conducted a public hearing on August 10, 2009 in Mathews, Louisiana at 4 p.m. to obtain comments relative to planning for and the submission of an application for funding under the FY2010-11 LCDBG Program; and

**WHEREAS**, after considering all comments received, it has been determined that the activity, which would derive the greatest benefit to the low/moderate income population of Lafourche Parish would be construction of a community center to house programs and services needed by area residents; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Joe Fertitta, Councilman, District 4 and Mr. Lindel Toups, Councilman, District 6; and

**NOW, THEREFORE BE IT RESOLVED**, by the Lafourche Parish Council, convened in regular session on September 22, 2009, that South Central Planning and Development Commission be hereby authorized to submit an application to the Louisiana Division of Administration, Office of Community Development, for funding under the FY2010-11 LCDBG Program for construction of a community center in the Alidore neighborhood and authorizing the Parish President to sign, execute, and administer any and all relevant documents.

**BE IT FURTHER RESOLVED**, that Lafourche Parish will use local funds to cover the pre-agreement, administrative and engineering fees required in the implementation of the grant, if funded; and

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution be forwarded to South Central Planning and Development Commission, Ms. Martha Cazaubon, P O Box 1870, Gray, LA 70359; Lafourche Parish Government Department of Community Services, Mr. Thomas Turner; Lafourche Parish Government Finance Department, Mr. Joel Doty; and the Office of the Parish Administrator.
