RESOLUTION NO. 09-392

RESOLUTION APPROVING THE PARISH PRESIDENT’S NOMINATION FOR THE POSITION OF DIRECTOR OF PARKS, RECREATION AND PUBLIC FACILITIES FOR THE LAFOURCHE PARISH GOVERNMENT.

WHEREAS, the Home Rule Charter of Lafourche Parish provides that the Parish President shall nominate Department Heads to head all Departments in her Administration; and

WHEREAS, the Parish President wishes to appoint and nominate Greg Sanamo as the Lafourche Parish Director of Parks, Recreation and Public Facilities; and

WHEREAS, this resolution was sponsored for Administration by Mr. Rodney Doucet, Councilman, District 8; and

WHEREAS, it is recommended by the Parish President of the Lafourche Parish Government that the Council approves this appointment and authorizes the Parish President to sign, execute and administer any and all relevant/related documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on October 27, 2009, and does hereby approve the Parish President’s appointment of Greg Sanamo for the position of Director of Parks, Recreation and Public Facilities at a salary of \$42,497.00 annually plus benefits and authorizes the Parish President to sign, execute and administer any and all relevant/related documents.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to Lafourche Parish Government Office of the Parish President, Department of Finance, Department of Human Resources, Department of Parks, Recreation and Public Facilities and the Office of the Parish Administrator.
