**RESOLUTION NO. 09-394**

**A RESOLUTION AUTHORIZING THE HIRING OF DUPLANTIS DESIGN GROUP, PC WITH LOCAL FUNDS FOR SERVICES NEEDED IN THE COMPLETION OF AN APPLICATION UNDER THE FY2010-2011 LOUISIANA COMMUNITY DEVELOPMENT BLOCK GRANT (LCDBG) PROGRAM TO PROVIDE WATER SYSTEM IMPROVEMENTS IN ALIDORE AND FOR DESIGN AND CONSTRUCTION INSPECTION SERVICES PENDING GRANT AWARD AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, Lafourche Parish will submit an application to the Louisiana Division of Administration, Office of Community Development for funding under the FY2010-2011 Community Development Block Grant (LCDBG) Program to provide water system improvements in Alidore; and

**WHEREAS**, professional engineering consulting services are required to complete the application and provide subsequent engineering and design services in accordance with the LCDBG regulations; and

**WHEREAS**, the Parish will use local funds for this project which will allow the Parish to obtain an additional point in the LCDBG ranking, increasing the chances of the parish to receive funding for this needed project; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

**NOW, THEREFORE BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on October 27, 2009, and does hereby authorize the hiring of Duplantis Design Group, PC, for professional services in connection with the preparation of an application to the FY 2010-2011 Louisiana Community Development Block Grant Program for water system improvements in Alidore and for engineering, design and construction inspection and that all such services shall be paid with local funds, pending grant award and authorizing the Parish President to sign, execute, and administer any and all relevant documents; and

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution be forwarded to South Central Planning and Development Commission, P O Box 1870, Gray, LA 70359; Lafourche Parish Government Department of Community Services, Department of Finance, and the Office of the Parish Administrator.
