RESOLUTION NO. 09-403

RESOLUTION IN SUPPORT OF THE FISCAL YEAR 2010/2011 CAPITAL OUTLAY APPROPRIATION REQUESTS BY LAFOURCHE PARISH GOVERNMENT TO THE STATE OF LOUISIANA THROUGH THE OFFICE OF FACILITY PLANNING & CONTROL.

WHEREAS, Lafourche Parish Government submitted Capital Outlay Appropriation requests to the State of Louisiana through the Office of Facility Planning & Control for the 2010/2011 fiscal year, for the following capital projects: 1) Laurel Valley Road Project and 2) South Lafourche Airport Corridor Project; and

WHEREAS, the Capital Outlay Appropriation requests were submitted on October 28, 2009 to meet the November 1, 2009 deadline and each project has a letter of support from the State Representative and State Senator representing Lafourche Parish where the projects are physically located; and

WHEREAS, this resolution was sponsored for Administration by Mr. Michael Delatte, Councilman, District 2; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council support the Capital Outlay Appropriation requests of Lafourche Parish Government.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on November 10, 2009, and does hereby support the Capital Outlay Appropriation requests of Lafourche Parish Government to the State of Louisiana through the Office of Facility Planning & Control for the 2010/2011 fiscal year, for the following capital projects: 1) Laurel Valley Road Project and 2) South Lafourche Airport Corridor Project.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to the Lafourche Parish Government Grants & Economic Development Office and the Office of the Parish Administrator.
