**RESOLUTION NO. 09-409**

**RESOLUTION APPROVING THE PURCHASE OF ONE (1) 40 KW GENERATOR FROM ARRCO IN THE AMOUNT OF \$22,817.00 UNDER STATE CONTRACT #408104 THROUGH THE DEPARTMENT OF PUBLIC WORKS FOR THE LOCKPORT FIELD OFFICE AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, the Department of Public Works is in need of one (1) 40 KW Generator for the Lockport Field Office to replace the generator that is out of service; and

**WHEREAS**, the Department of Public Works through Governor’s Office of Community Development, Grant LGAP CFMS #676882 will purchase a 40 KW Generator in the amount of \$22,817.00; and

**WHEREAS**, Department of Public Works will purchase this generator through State Contract # 408104; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approves the purchase of one (1) 40 KW Generator from ARRCO in the amount of \$22,817.00 under State Contract #408104 through the Department of Public Works for the Lockport Field Office and authorizes the Parish President to sign, execute, and administer any and all relevant documents.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on November 10, 2009, and does hereby authorize the purchase of one (1) 40 KW Generator from ARRCO for a total of \$22,817.00 under State Contract # 408104 through the Department of Public Works for the Lockport Field Office and authorizes the Parish President to sign, execute, and administer any and all relevant documents.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution shall be forwarded to; Lafourche Parish Government Department of Public Works, Office of Emergency Preparedness, Department of Finance, and the Office of the Parish Administrator.
