A RESOLUTION AUTHORIZING THE HIRING OF DUPLANTIS DESIGN GROUP, PC FOR A MODULAR BUILDING PROJECT FOR THE THIBODAUX HEAD START SITE AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, Lafourche Parish Head Start is in need of architectural services to prepare bid specifications necessary to facilitate the installation and completion of a modular building for the purpose of a Head Start site in Thibodaux; and,

WHEREAS, the project will be bid in two phases; and

WHEREAS, Community Services previously applied for and received funding from Entergy for this purpose; and

WHEREAS, this resolution was sponsored for Administration by Mr. Jerry Jones, Councilman, District 1; and

NOW, THEREFORE BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on November 10, 2009, and does hereby authorize the hiring of Duplantis Design Group, PC, for professional services in connection with the Modular Building Project for the Thibodaux Head Start Site; and authorizing the Parish President to sign, execute, and administer any and all relevant documents; and
