RESOLUTION NO. 09-413

RESOLUTION APPROVING CHANGE ORDER NO. 1 FOR THE PROJECT ENTITLED GENERAL MAINTENANCE CONTRACT ROAD SALES TAX DISTRICT 2 FOR AN INCREASE IN CONTRACT PRICE BY \$4,980.00 FOR ADDITIONAL ITEMS AND AN INCREASE OF CONTRACT DAYS; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID CHANGE ORDER AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, this Change Order is being presented to include the attached additional items of digging new ditches, digging outfall canals and installing side drain pipe; and

WHEREAS, the original items contract price of \$1,732,670.00 will be increased by this Change Order in the amount \$4,980.00 for a new contract price totaling \$1,737,650.00; and

WHEREAS, 18 additional days are requested to complete work associated with these items; and

WHEREAS, it is the recommendation of this Administration that said Change Order be accepted; and

WHEREAS, this resolution was sponsored for Administration by Mr. Rodney Doucet, Councilman, District 8; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council authorize the Parish President to sign said Change Order and execute and administer any and all relevant documents.

BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on November 10, 2009, and does hereby approve Change Order No. 1 for General Maintenance Contract, Road Sales Tax District 2 increasing the contract price by \$4,980.00 for additional items, and authorizing the Parish President to sign said Change Order and execute and administer any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this Resolution shall be forwarded to Picciola Construction Company, Inc., Post Office Box 749, Cut Off, Louisiana 70345; Lafourche Parish Government Department of Finance; and the Office of the Parish Administrator.
