

On motion by Louis Richard, seconded by Phillip Gouaux, the following resolution was introduced and adopted:

**RESOLUTION NO. 09-415**

**RESOLUTION APPROVING THE EXTENSION OF THE TWO YEAR MAINTENANCE BOND AS REQUIRED IN SECTION 19:377.B, MAINTENANCE OF IMPROVEMENTS OF THE LAFOURCHE PARISH SUBDIVISION REGULATIONS BETWEEN THE LAFOURCHE PARISH COUNCIL AND OLYMPIA CONSTRUCTION, INC. TO EXTEND THE MAINTENANCE BOND ON ABBEY GLEN SUBDIVISION FOR AN ADDITIONAL THIRTY (30) DAYS AND AUTHORIZES THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID AGREEMENT(S).**

**WHEREAS**, Serenity Drive, after being monitored for two (2) years has several cracked concrete panels that shall be repaired by replacement at the following locations:

- a.) Across from 905 Serenity Drive by catch basin
- b.) Across from 900 Serenity Drive
- c.) By drainage Canal
- d.) At 838 Serenity Drive
- e.) Two (2) at 913 Serenity Drive and catch basin; and

**WHEREAS**, Olympia Construction, Inc. represented by Mr. Mark Bowlin; has agreed to replace the cracked panels; and

**WHEREAS**, the Department of Public Works would re-inspect at the end of the additional thirty (30) days to see if panels have been replaced on Serenity Drive (Abbey Glen Subdivision), Councilmatic District 3; and

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on November 24, 2009, and does hereby approve an agreement between the Lafourche Parish Council and Mark Bowlin, Olympia Construction, Inc. for the extension of the two (2) year maintenance bond to December 29, 2009; and authorizes the Parish President to sign, execute and administer said agreement(s).

**BE IT FURTHER RESOLVED**, that a certified copy of this Resolution shall be forwarded to Mark Bowlin, Olympia Construction, Inc.; Lafourche Parish Finance Department, and the Parish Administrator.
