**RESOLUTION NO. 09-423**

**A RESOLUTION APPROVING A CONTRACT BETWEEN LAFOURCHE PARISH GOVERNMENT AND ANGELETTE-PICCIOLA, LLC, FOR THE PROJECT ENTITLED CUT OFF LIFT BRIDGE REPAIRS AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID CONTRACT AND ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, the Cut Off Lift Bridge requires necessary repairs and improvements; and
