RESOLUTION NO. 09-425

RESOLUTION APPOINTING ONE (1) COMMISSIONER TO REPRESENT THIBODAUX CITY POLICE ON THE LAFOURCHE PARISH YOUTH AND PLANNING BOARD.

WHEREAS, Arlene Rodriguez, serves on the Lafourche Parish Children and Youth Planning Board and represents Thibodaux City Police on the Board; and

WHEREAS, according to the Lafourche Parish Government's records, Arlene Rodriguez's term expired on November 12, 2009; and

WHEREAS, in a letter from the City of Thibodaux, Chief of Police Mr. Craig Melancon recommends Detective Aaron Barnes be appointed to the Lafourche Parish Children and Youth Planning Board; and

WHEREAS, this resolution was sponsored for Administration by Mr. Louis Richard, District 3; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this recommendation.
