

On motion by Mr. Phillip Gouaux, seconded by Mr. Lindel Toups, the following resolution was introduced and adopted;

RESOLUTION NO. 09-439

A RESOLUTION ACCEPTING THE LOW BID FOR THE MODULAR CLASSROOM BUILDING FOR LAFOURCHE PARISH GOVERNMENT HEAD START – 2009 AWARDING THE LOW BID BEING SUBMITTED BY COMARK BUILDING SYSTEMS, INC., IN THE AMOUNT OF \$74,365.00 AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID CONTRACT AND ASSOCIATED DOCUMENTS AND AMENDMENTS.

WHEREAS, six (6) bids were received and read publicly on December 15, 2009 as follows:

WHEREAS, the lowest bidder is Comark Building System, Inc.; and

WHEREAS, this project was approved in the 2009 Capital Project detail to be funded by Head Start; and

WHEREAS, it is the recommendation of Duplantis Design Group and the Administration of Lafourche Parish Government that the low bid of \$74,365.00 be accepted; and

WHEREAS, this resolution was sponsored for Administration by Mr. Phillip Gouaux, Councilman, District 7; and

WHEREAS, the Office of Head Start has informed us that this bid should be approved and the contract finalized in the year 2009; and

WHEREAS, it is recommended by the Administration that the Lafourche Parish Council accept the low bid of \$74,365.00 from Comark Building Systems, Inc. and authorize the Parish President to sign, execute, and administer said contract and any and all relevant documents and amendments.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in Special Session on December 22, 2009, and does hereby accept the low bidder, Comark Building Systems, Inc. in the amount of \$74,365.00 and authorizes the Parish President to sign, execute and administer said contract and all associated documents and amendments.

THEREFORE, BE IT FURTHER RESOLVED, that a certified copy of this Resolution shall be forwarded to Duplantis Design Group, Comark Building Systems, Inc., Office of Community Services, Head Start Office, Attn: Martha Babin, and the Office of the Parish Administrator.
