RESOLUTION NO. 09-442

RESOLUTION ACCEPTING THE LOW BID FROM WEEK’S MARINE IN THE AMOUNT OF \$1,720,237.00 FOR THE NORTHWEST LITTLE LAKE MARSH CREATION & ENHANCEMENT PROJECT, AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER A CONTRACT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, five (5) bids were received for this project and opened on December 7, 2009 at 10:00 am as follows:

Javelier Construction	\$1,732,906.70
Coastal Dredging Co.	\$1,800,500.10
Wilco Industrial Service	\$2,750,315.78
Great Southern Dredging	\$3,467,738.00

WHEREAS, the lowest responsible bidder was Week’s Marine in the amount of \$1,720,237.00; and

WHEREAS, it is recommended by this Administration that the low bid of Week’s Marine be accepted; and

WHEREAS, this resolution was sponsored for Administration by Mr. Rodney Doucet, Councilman, District 8; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves the low bid from Week’s Marine for the Northwest Little Lake Marsh Creation & Enhancement Project in the amount of \$1,720,237.00 and authorizes the Parish President to sign, execute, and administer said contract and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in special session on December 22, 2009, and does hereby approve the low bid from Week’s Marine in the amount of \$1,720,237.00 for Northwest Little Lake Marsh Creation & Enhancement Project and authorizes the Parish President to sign, execute, and administer said contract and any and all relevant documents.
