

On motion by Lindel Toups, seconded by Joe Fertitta, the following resolution was introduced and adopted:

RESOLUTION NO. 14-009

RESOLUTION APPROVING THE ATTACHED BASIC COOPERATIVE ENDEAVOR AGREEMENT, TO BE TAILORED INDIVIDUALLY TO EACH PARTICIPATING SENIOR CITIZENS CENTER, FOR THE PURPOSE OF CONTINUING THE IMPLEMENTATION OF THE “LAFOURCHE ON THE MOVE” PROGRAM; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID AGREEMENTS AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, in 2004, the Lafourche Parish President proposed a Parish-wide effort called “Lafourche on the Move” to encourage physical activity and improved health in conjunction with a Nationwide Campaign; and

WHEREAS, the Lafourche Parish Council appropriated funding for this program in the 2005, 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013 and 2014 Maintenance and Operating Budget to include Senior Citizens Centers to enhance public participation and physical activity; and

WHEREAS, in the continued implementation of the “Lafourche on the Move” Program, the Parish seeks to create Cooperative Endeavor Agreements with each Senior Citizens Center that has fulfilled the 2013 requirements including:

1. Thibodaux Senior Citizens Center
2. Ward 6 Senior Citizens Center
3. Bayou Blue Senior Citizens Center
4. Gheens Senior Citizens Center
5. Raceland Senior Citizens Center
6. Lockport Senior Citizens Center
7. Larose Senior Citizens Center
8. Cut Off Senior Citizens Center
9. Golden Meadow Senior Citizens Center

WHEREAS, this resolution was sponsored for Administration by Mr. Phillip Gouaux, Councilman, District 7; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves the attached basic Cooperative Endeavor Agreement, to be tailored individually to each participating Senior Citizens Center, for the purpose of continuing the implementation of the “Lafourche on the Move” Program; and authorizing the Parish President to sign, execute and administer said agreements and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on January 14, 2014, and does hereby approve the attached basic Cooperative Endeavor Agreement, to be tailored individually to each participating Senior Citizens Center, for the purpose of continuing the implementation of the “Lafourche on the Move” Program; and authorizing the Parish President to sign, execute and administer said agreements and any and all relevant documents.

Box 662, Golden Meadow, Louisiana 70357); and the Lafourche Parish Government: Department of Finance, Department of Parks and Recreation, and the Office of the Parish Administrator.
