**RESOLUTION NO. 14-013**

**RESOLUTION APPROVING ADDENDUM #2 TO THE VISIONLIVE SUBSCRIPTION SERVICES AGREEMENT BETWEEN LAFOURCHE PARISH GOVERNMENT AND VISION INTERNET PROVIDERS, INC. TO PROVIDE FOR ADDITIONAL CUSTOMIZED CODE FOR THE LAFOURCHEGOV.ORG WEBSITE DESIGN; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, Vision Internet Providers, Inc. shall perform services as described on Addendum #2 Scope of Services; and

**WHEREAS**, Lafourche Parish Government shall pay a one-time fee of \$540.00 to Vision Internet Providers, Inc. for the development of customized code for the website homepage weather widget to display three to four days of forecasted weather conditions for the Parish; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Michael Delatte, Councilman, District 2; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approves Addendum #2 to the VisionLive Subscription Services Agreement between Lafourche Parish Government and Vision Internet Providers, Inc. for additional customized code for the lafourchegov.org website design; and authorizes the Parish President to sign, execute and administer said agreement and any and all relevant documents.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on January 14, 2014, and does hereby approve Addendum #2 to the VisionLive Subscription Services Agreement between Lafourche Parish Government and Vision Internet Providers, Inc. for additional customized code for the lafourchegov.org website design; and authorizes the Parish President to sign, execute and administer said agreement and any and all relevant documents.
