

On motion by Jerry Jones, seconded by Lindel Toups, the following resolution was introduced and adopted:

RESOLUTION NO. 14-015

RESOLUTION APPROVING AMENDMENT NO. 3 TO THE CONTRACT BETWEEN LAFOURCHE PARISH GOVERNMENT AND MOSQUITO CONTROL OF LAFOURCHE, LLC TO INCREASE THE CONTRACT PRICE DUE TO FLUCTUATIONS IN THE CONSUMER PRICE INDEX AND TO EXTEND THE CONTRACT; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID AMENDMENT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, currently the Lafourche Parish Government compensates Mosquito Control of Lafourche, LLC in the amount of \$41,503.85 payable monthly; and

WHEREAS, due to fluctuations in the Consumer Price Index and as stated in the Contract the current monthly rate of compensation shall be increased; and

WHEREAS, the new monthly rate of compensation shall be \$42,274.96 monthly; and

WHEREAS, the contract shall be extended for three (3) consecutive years beyond the current end date of July 31, 2014; and

WHEREAS, this resolution was sponsored for Administration by Mr. Michael Delatte, Councilman, District 2; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves Amendment No. 3 to the contract between Lafourche Parish Government and Mosquito Control of Lafourche, LLC to increase the contract price due to fluctuations in the consumer price index and to extend the contract; and authorizes the Parish President to sign, execute and administer said amendment and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on January 14, 2014, and does hereby approve Amendment No. 3 to the contract between Lafourche Parish Government and Mosquito Control of Lafourche, LLC to increase the contract price due to fluctuations in the consumer price index and to extend the contract; and authorizes the Parish President to sign, execute and administer said amendment and any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to Mosquito Control of Lafourche, Attn: Mr. Steven Pavlovich, 1000 Labarre Road, Metairie, Louisiana 70001; and Lafourche Parish Government: Department of Finance, Office of Risk Management, and the Office of the Parish Administrator.
