**RESOLUTION REAPPOINTING ONE (1) COMMISSIONER TO THE
LAFOURCHE PARISH ANIMAL SHELTER ADVISORY BOARD.**

WHEREAS, Mr. Eugene Dial serves on the Lafourche Parish Animal Shelter Advisory Board;

WHEREAS, according to the Lafourche Parish Government's records, Mr. Dial's term expired on December 13, 2013; and

WHEREAS, Councilman Aaron Caillouet recommends Mr. Eugene Dial to represent Councilmatic District 3; and
