**RESOLUTION REAPPOINTING ONE (1) COMMISSIONER TO THE
LAFOURCHE PARISH ANIMAL SHELTER ADVISORY BOARD.**

WHEREAS, Mr. Richmond Boyd serves on the Lafourche Parish Animal Shelter Advisory Board; and

WHEREAS, according to the Lafourche Parish Government's records, Mr. Boyd's term expired on January 10, 2014; and

WHEREAS, Councilman Jerry Jones recommends Mr. Richmond Boyd to represent Councilmatic District 1; and

WHEREAS, this resolution was sponsored for Administration by Mr. Jerry Jones, Councilman, District 1; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this recommendation.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on January 14, 2014, and does hereby reappoint Mr. Richmond Boyd on the Lafourche Parish Animal Shelter Advisory Board to serve a three (3) year term beginning January 14, 2014, and ending January 13, 2017.
