RESOLUTION NO. 14-023

A RESOLUTION ACCEPTING THE LOW BID OF UTILITY CONSTRUCTION SERVICES, LLC IN THE AMOUNT OF \$85,000.32 FOR PRE-STORM RECREATION FACILITY REPAIRS IN RECREATION DISTRICT NO. 3 AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER AN AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, repairs are needed to Larose Parks; and

WHEREAS, two bids were received on December 12, 2013 with Utility Construction Services, LLC being the low bidder in the amount of \$85,000.32; and

WHEREAS, this resolution was sponsored for Administration by Mr. Jerry LaFont, Councilman, District 8; and

WHEREAS, it is the recommended by the Administration of Lafourche Parish Government that the Council accept the low bid of Utility Construction Services, LLC in the amount of \$85,000.32 for Pre-Storm Recreation Facility Repairs in Recreation District No. 3 and authorizing the Parish President to sign, execute and administer an agreement and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on January 14, 2014, does hereby accept the low bid of Utility Construction Services, LLC in the amount of \$85,000.32 for Pre-Storm Recreation Facility Repairs in Recreation District No. 3 and authorizes the Parish President to sign, execute and administer an agreement and any and all relevant documents.
