RESOLUTION APPROVING THE LOW BID OF BYRON E. TALBOT CONTRACTOR, INC. IN THE AMOUNT OF \$359,500.00 FOR THE PROJECT ENTITLED DRAINAGE IMPROVEMENTS NEAR WEST 111TH AND EAST 86TH STREETS AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER AN AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.
