RESOLUTION TO PURCHASE THREE (3) BOBCAT COMPACT EXCAVATORS FROM DUHON MACHINERY, A BOBCAT DEALER, THROUGH STATE CONTRACT FOR A TOTAL OF \$133,776.00 FOR THE LAFOURCHE PARISH GOVERNMENT DEPARTMENT OF PUBLIC WORKS AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, three (3) Bobcat Compact Excavators will be purchased from Duhon Machinery, a Bobcat Dealer, State Contract #409612, T# 92699, at \$44,592.00 each for the total amount of \$133,776.00; and

WHEREAS, the funding will come from RSTD-A; and

WHEREAS, this resolution was sponsored for Administration by Mr. Joseph Fertitta, Councilman, District 4; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approve the purchase of three (3) Bobcat Compact Excavators from Duhon Machinery, a Bobcat Dealer, through State Contract for a total of \$133,776.00 for the Lafourche Parish Government Department of Public Works and authorizing the Parish President to sign, execute and administer any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on February 25, 2014, and does hereby approve the purchase of three (3) Bobcat Compact Excavators from Duhon Machinery, a Bobcat Dealer, through State Contract, for a total of \$133,776.00 for the Lafourche Parish Government Department of Public Works and authorizing the Parish President to sign, execute and administer any and all relevant documents.
