

On a motion by Jerry LaFont, seconded by Lindel Toups the following resolution was introduced and adopted:

RESOLUTION NO. 14-047

RESOLUTION APPROVING A COOPERATIVE ENDEAVOR AGREEMENT BETWEEN LAFOURCHE PARISH GOVERNMENT AND LAFOURCHE PARISH DRAINAGE DISTRICT NO. 1 FOR FUNDING IN THE AMOUNT OF \$49,092.00 FROM DRAINAGE DISTRICT NO. 1 FOR THE PURCHASE OF A BOBCAT COMPACT EXCAVATOR AND BUSH HOG TO BE PURCHASED BY LAFOURCHE PARISH GOVERNMENT, AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, Lafourche Parish Drainage District No. 1 has agreed to provide funding in the amount of \$49,092.00 to Lafourche Parish Government for the purchase of one (1) Bobcat Compact Excavator and Bush Hog for the Department of Public Works, to be used exclusively within Drainage District No. 1; and

WHEREAS, Lafourche Parish Government will purchase one (1) Bobcat Compact Excavator and Bush Hog for the Department of Public Works from Duhon Machinery in the amount of \$49,092.00 to be used exclusively within Drainage District No. 1; and

WHEREAS, this resolution was sponsored for Administration by Mr. Jerry LaFont, Councilman, District 8; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Lafourche Parish Council approve a Cooperative Endeavor Agreement between Lafourche Parish Government and Lafourche Parish Drainage District No. 1 for funding in the amount of \$49,092.00 from Drainage District No. 1 for the purchase of a Bobcat Compact Excavator and Bush Hog to be purchased by Lafourche Parish Government, and authorizing the Parish President to sign, execute and administer said agreement and any and all relevant documents.

THEREFORE BE IT RESOLVED, that the Lafourche Parish Council, convened in regular session on February 25, 2014, and hereby approves a Cooperative Endeavor Agreement between Lafourche Parish Government and Lafourche Parish Drainage District No. 1 for funding in the amount of \$49,092.00 from Drainage District No. 1 for the purchase of a Bobcat Compact Excavator and Bush Hog to be purchased by Lafourche Parish Government, and authorizing the Parish President to sign, execute and administer said agreement and any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to Lafourche Parish Drainage District No. 1, Attn: Albert Guidry, P O Box 338, Larose, LA 70373; Lafourche Parish Government Department of Public Works; Department of Finance; and the Office of Parish Administrator.
