**RESOLUTION NO. 14-050**

**RESOLUTION REAPPOINTING ONE (1) COMMISSIONER TO REPRESENT THE FRIENDS OF THE CENTER ON THE SPECIAL EDUCATION DISTRICT NO. 1 BOARD.**

**WHEREAS**, Mr. Kristian Gaudet was appointed to the Special Education District No. 1 Board on August 12, 2008, as the recommendation of the Friends of the Center; and

**WHEREAS**, Mr. Gaudet's term is set to expire on February 25, 2014; and

**WHEREAS**, Mr. Gaudet is interested in remaining a board member; and

**WHEREAS**, in a letter from the Friends of the Center, it states that at the regular monthly meeting of the Board of Commissioners on January 16, 2014, the Board voted unanimously to recommend to the Lafourche Parish Council that Mr. Kristian Gaudet remain a Commissioner for Special Education District No. 1 Board; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Jerry Lafont, District 8; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this recommendation.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on February 25, 2014, and does hereby reappoint Mr. Kristian Gaudet to the Special Education District No. 1 Board to the six (6) year term beginning February 25, 2014, and ending February 24, 2020.
