

On motion by Lindel Toups, seconded by Joe Fertitta, the following resolution was introduced and adopted;

**RESOLUTION NO. 14-051**

**RESOLUTION APPROVING A CONTRACT BETWEEN LAFOURCHE PARISH GOVERNMENT AND DUPLANTIS DESIGN GROUP, PC, FOR ENGINEERING SERVICES FOR THE BULKHEAD ON INDUSTRIAL BOULEVARD ALONG BAYOU LAFOURCHE/GIWW PROJECT AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID CONTRACT AND ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, the services of an engineering firm are needed to assist with the bulkhead on Industrial Boulevard along Bayou Lafourche/GIWW project; and

**WHEREAS**, the existing bulkhead on Industrial Boulevard along Bayou Lafourche/GIWW failed and a nearby building is at risk of failure; and

**WHEREAS**, the Design will consist of a new steel sheet pile bulkhead to stabilize the bank; and

**WHEREAS**, the funding for this project will come from the 2014 Capital Budget; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

**WHEREAS**, it is recommended by the Administration of Lafourche Parish Government that the Council does hereby approve a contract between Lafourche Parish Government and Duplantis Design Group, PC, for engineering services for the Bulkhead on Industrial Boulevard along Bayou Lafourche/GIWW project and authorizing the Parish President to sign, execute and administer said contract and any and all relevant documents.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on February 25, 2014, and does hereby approve a contract between Lafourche Parish Government and Duplantis Design Group, PC, for engineering services for the Bulkhead on Industrial Boulevard along Bayou Lafourche/GIWW project and authorizing the Parish President to sign, execute and administer said contract and any and all relevant documents.
