RESOLUTION NO. 14-053

A RESOLUTION ACCEPTING THE LOW BID OF COASTAL MARINE CONTRACTORS, LLC IN THE AMOUNT OF \$1,028,044.94 FOR THE LEEVILLE PUBLIC BOAT LAUNCH AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER AN AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, five (5) bids were received on November 19, 2013 as follows:

WHEREAS, Coastal Marine Contractors, LLC, is the lowest responsive bidder in the amount of \$1,028,044.94 and said bid is deemed to be in order; and

WHEREAS, it is the recommendation of Picciola & Associates, Inc. and this Administration that the low bid of Coastal Marine Contractors, LLC, be accepted; and

WHEREAS, the State of Louisiana Department of Wildlife and Fisheries has submitted a letter serving as "Notice to Proceed" to award the construction contract to Coastal Marine Contractors, LLC in the amount of \$1,028,044.94; and

WHEREAS, this resolution was sponsored for Administration by Mr. Daniel Lorraine, Councilman, District 9; and

WHEREAS, it is recommended by the Administration of Lafourche Parish Government that the Council does hereby accept the low bid of Coastal Marine Contractors, LLC, in the amount of \$1,028,044.94 for the Leeville Public Boat Launch and authorizes the Parish President to sign, execute and administer an agreement and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on February 25, 2014, and does hereby accept the low bid of Coastal Marine Contractors, LLC, in the amount of \$1,028,044.94 for the Leeville Public Boat Launch and authorizes the Parish President to sign, execute and administer an agreement and any and all relevant documents.
