RESOLUTION NO. 14-056

RESOLUTION REQUESTING THAT THE LAFOURCHE PARISH COUNCIL APPROVE AND AUTHORIZE MIKE GEE, ATTORNEY FOR LAFOURCHE PARISH, TO SETTLE CASE #116377 FOR \$115,000.00 WITH CHAD JARREAU AND \$15,000.00 WITH CHARLES JARREAU ON BEHALF OF THE LAFOURCHE PARISH GOVERNMENT AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID SETTLEMENT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, on or about March 1, 2010 an employee of the Parish was attempting to make a left hand turn to enter the McCloud Pump Station from Hwy 308; and

WHEREAS, a vehicle driven by Chad Jarreau with one passenger, Charles Jarreau, was traveling South on Hwy 308 striking the drivers side of the Parish vehicle as it attempted to make the turn; and

WHEREAS, this resolution was sponsored for Administration by Mr. Joseph Fertitta, Councilman, District 4; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves and authorizes Mike Gee, Attorney for Lafourche Parish Government, to settle case #C-116377 for \$115,000.00 with Chad Jarreau and \$15,000.00 with Charles Jarreau and does hereby authorize the Parish President to sign, execute and administer said settlement and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on March 11, 2014, and hereby approves and authorizes Mike Gee, Attorney for Lafourche Parish Government, to settle case #C-116377 for \$115,000.00 with Chad Jarreau and \$15,000.00 with Charles Jarreau and does hereby authorize the Parish President to sign, execute and administer said settlement and any and all relevant documents.
