**WHEREAS**, the funding for this project is coming from 2014 Capital Projects #14015; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Jerry Jones, Councilman, District 1; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council accepts the low quote of Scott Fence USA, LLC for the purchase and installation of an automatic gate at the Thibodaux Field Office and authorizes the Parish President to sign, execute and administer said agreement and any and all relevant documents.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on March 11, 2014, and does hereby accept the low quote of Scott Fence USA, LLC for the purchase and installation of an automatic gate at the Thibodaux Field Office and authorizes the Parish President to sign, execute and administer said agreement and any and all relevant documents.
