

On motion by Aaron Caillouet, seconded by John Arnold, the following resolution was introduced and adopted;

RESOLUTION NO. 14-065

A RESOLUTION APPROVING A COOPERATIVE ENDEAVOR AGREEMENT BETWEEN THE LSU AGCENTER AND LAFOURCHE PARISH GOVERNMENT TO SUPPORT AND ADMINISTER LOUISIANA COOPERATIVE UNITS OFF CAMPUS AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, in 1914 Congress passed the Smith-Lever Act which created a cooperative extension service system that links land grant campus faculty with those seeking information in off campus locations; and

WHEREAS, this is achieved through a partnership between the United States Department of Agriculture, the Louisiana State University AgCenter and local governments; and

WHEREAS, this cooperative agreement is entered into in order to ensure continued informal educational programming from the LSU AgCenter; and

WHEREAS, the agreement shall be effective from January 1, 2014 through December 31, 2014; and

WHEREAS, this resolution was sponsored for Administration by Mr. Aaron Caillouet, Councilman, District 3; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves said Cooperative Endeavor Agreement between Lafourche Parish Government and the LSU AgCenter to support and administer Louisiana Cooperative Units off campus and authorizes the Parish President to sign, execute, and administer said agreement and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on March 11, 2014, and does hereby approve said Cooperative Endeavor Agreement between Lafourche Parish Government and the LSU AgCenter to support and administer Louisiana Cooperative Units off campus and authorizes the Parish President to sign, execute, and administer said agreement and any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to LSU AgCenter, Attn: Mike Hebert, Post Office Box 429, Thibodaux, LA 70302, Lafourche Parish Government Department of Finance, and the Office of the Parish Administrator.
