

On a motion by Michael Delatte, seconded by Jerry Jones the following resolution was introduced and adopted:

RESOLUTION NO. 14-067

RESOLUTION APPROVING THE “SOCIAL SERVICES CONTRACT - COMMUNITY SERVICES BLOCK GRANT” (WHICH INCLUDES AMENDMENT #1) BETWEEN THE LOUISIANA WORKFORCE COMMISSION, OFFICE OF WORKFORCE DEVELOPMENT AND LAFOURCHE PARISH COUNCIL OFFICE OF COMMUNITY ACTION AS THE SUBGRANTEE, TO RECEIVE AND ADMINISTER THE COMMUNITY SERVICE BLOCK GRANT (CSBG) FUNDS TO PROVIDE ASSISTANCE TO LOW INCOME FAMILIES IN LAFOURCHE PARISH IN ACCORDANCE WITH STATE REQUIREMENTS AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID AGREEMENT AND AMENDMENT AND ANY AND ALL RELEVANT DOCUMENTS IN ACCORDANCE WITH THE PROVISIONS OF THE COMMUNITY SERVICES BLOCK GRANT ACT OF 1981.

WHEREAS, the State of Louisiana, Department of Labor annually offers program dollars under the Community Service Block Grant to attain a measurable and positive impact on the causes of poverty in Lafourche Parish; and

WHEREAS, the Community Services Block Grant sub-grantee assures that activities funded on the local level conform to assist low income individuals, including families, and individuals who are attempting to transition off of a State program carried out under part A of Title IV of the Social Security Act, homeless individuals and families, migrants, and elderly low-income individuals and families; and

WHEREAS, the 2013-2015 grant from the State offers Two Hundred Fifty-Three Thousand One Hundred Forty Seven Dollars (\$253,147.00) for said program; and

WHEREAS, his contract shall begin on October 1, 2013 and shall end on September 30, 2015; and

WHEREAS, the Parish of Lafourche serves as fiscal agent for said grant under the direction of the Department of Community Services: Office of Community Action and advised by the Advisory Board; and

WHEREAS, this contract includes Amendment No. 1 to change subgrantee’s signatory authority on page 30 to Charlotte A. Randolph, Parish President; and

WHEREAS, this resolution was sponsored for Administration by Mr. Daniel Lorraine, Councilman, District 9; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves the “Social Services Contract - Community Services Block Grant” (which includes Amendment #1) between the Louisiana Workforce Commission, Office of Workforce Development and Lafourche Parish Council Office of Community Action as the Subgrantee, to receive

and administer the Community Service Block Grant (CSBG) funds to provide assistance to low income families in Lafourche Parish in accordance with State requirements and authorizing the Parish President to sign, execute and administer said agreement and amendment and any and all relevant documents in accordance with the provisions of the community services block grant act of 1981.

THEREFORE BE IT RESOLVED , that the Lafourche Parish Council convened in regular session on March 25, 2014, and does hereby approve the “Social Services Contract - Community Services Block Grant” (which includes Amendment #1) between the Louisiana Workforce Commission, Office of Workforce Development and Lafourche Parish Council Office of Community Action as the Subgrantee, to receive and administer the Community Service Block Grant (CSBG) funds to provide assistance to low income families in Lafourche Parish in accordance with State requirements and authorizing the Parish President to sign, execute and administer said agreement and amendment and any and all relevant documents in accordance with the provisions of the community services block grant act of 1981.

BE IT FURTHER RESOLVED, that a certified copy of this resolution be forwarded to Louisiana Workforce Commission, Office of Workforce Development, Attn: CSBG Supervisor, P.O. Box 94094, Baton Rouge, LA 70804-9094, Lafourche Parish Government Dept. of Community Services, Office of Community Action, Department of Finance, Office of Risk Management, and the Office of the Parish Administrator.
