RESOLUTION NO. 14-070

A RESOLUTION APPROVING THE PURCHASE OF ONE (1) F150 FORD TRUCK (4WD/REGULAR CAB/SHORT BED) FOR THE DEPARTMENT OF PUBLIC WORKS THIBODAUX FIELD OFFICE IN THE AMOUNT OF \$21,802.00 AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, the Department of Public Works Thibodaux Field Office is in need of one (1) truck for replacement; and

WHEREAS, one (1) F150 Ford Truck (4WD/Regular Cab/Short Bed) will be purchased through State Purchasing from Lafourche Ford, Commodity # 070-48-018462, Contract# 409705, Line# 86, for a cost of Twenty-One Thousand Eight Hundred Two Dollars (\$21,802.00); and

WHEREAS, funds will come from the 2014 Drainage Capital Outlay Budget, Project Code 13010; and

WHEREAS, this resolution was sponsored for Administration by Mr. Aaron Caillouet, Councilman, District 3; and

WHEREAS, it is recommended by the Administration of Lafourche Parish Government that the Council approve the purchase of one (1) F150 Ford Truck (4WD/Regular Cab/Short Bed) for the Department of Public Works Thibodaux Field Office in the amount of \$21,802.00 and authorizes the Parish President to sign, execute and administer any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on March 25, 2014, and does hereby approve the purchase of one (1) F150 Ford Truck (4WD/Regular Cab/Short Bed) for the Department of Public Works Thibodaux Field Office in the amount of \$21,802.00 and authorizes the Parish President to sign, execute and administer any and all relevant documents
